Dear Parent,

As you are aware, the school believes in maintaining a high academic excellence with a plethora of activities executed with utmost dedication while keeping best interests of your wards in mind.

It has been our endeavor to do so and keeping its philosophy alive as well as to run the institution smoothly, the management has decided to affix the school fee structure for academic year 2019-20 and the same is attached herewith.

This is to intimate you of the fees in advance, as is the practice every year before the new term begins. The school's stand with respect this fixation is as follows.

The School has challenged the constitutional validity of the Gujarat Self Financed Schools (Regulation of Fees) Act, 2017, hereinafter referred to as the 'Act', which is pending before the Hon'ble Supreme Court of India.

The School was permitted to charge fees for the academic year 2017-18 as per the previous year's fees as an interim measure. The FRC constituted under the Act, which is under challenge before the Hon'ble Supreme Court, has determined the fees of the School for the A.Y.2017-18 and 2018-19. The School has challenged the fees determined by the FRC before the Appellate authority, which is pending as on this date.

Since the challenge of the fees determined by the FRC and the constitutional validity of the Act are pending before the Authority and the Apex Court respectively, the School is within its right to charge the fees for A.Y. 2018-19 and for the subsequent years as per the fees of A.Y. 2016-17, subject to the final outcome of the challenges.

The School reiterates that in the event of final adjudication of fees by the concerned authorities/Courts, the School shall refund the excess fees charged, if any.

Till then, we urge our parents to continue paying the fees as decided by the School, which is as per the law/direction/orders of the Courts, in the overall interest of the students, who are entitled to quality education.
